TERMS:

Pets are accepted for grooming only under the following conditions:

1. **Health:** The animal is fit, healthy, and free of any contagious diseases. Any grooming which takes place on an elderly animal or animal with health problems will be at the owner's risk. Grooming may expose or aggravate a pre-existing health/skin problem for which My Two Dogs, Inc. cannot be held liable. Senior pets also have a greater chance of injury during grooming. In the event of any injury or health concern, My Two Dogs, Inc. is authorized to contact a Veterinary surgeon and authorize the Vet to treat the pet as necessary at the owner's expense.
2. **Vaccinations:** My dog's vaccinations are current and in compliance with the laws of the City of New York. I have also provided My Two Dogs, Inc. with a copy of my dog's vaccinations, and will continue to do so as necessary.
3. **De-Matting & Shaving:** De-matting may cause patchiness and hair loss. Consent to remove the matted hair is on this understanding. A matted pet is at greater risk of injury, nicks, clipper irritation, mental and physical stress and trauma. My Two Dogs, Inc. reserves the right to refuse to de-matt any dog that will be caused unnecessary discomfort when there are alternative options such as shaving. Shaving may expose pre-existing skin conditions, and will dramatically alter your dog's appearance. Consent to shave the pet is on this understanding.
4. **Sitting Fee:** Payment will be made as per price list/quote and owners must collect pets at time stated. My Two Dogs, Inc. will contact the owner approximately 15 minutes before the pet is ready. Uncollected pets will be charged a sitting fee of \$10/30 minutes after the first 30 minutes.
5. **Pictures:** All photos taken of your pet while at the facility are property of My Two Dogs, Inc., and may be used in promotional material, including but not limited to print, video, and internet.
6. **Appointments and Cancellation Policy:** I understand that a credit card is required to make an appointment, and that My Two Dogs, Inc. will keep this information on file. If I need to cancel my appointment, I will give My Two Dogs, Inc. 24 hours notice or hereby authorize My Two Dogs, Inc. to charge my credit card a \$20 non-refundable cancellation fee at the time of my appointment.
7. **Sedatives:** For aggressive/anxious dogs with whom all other options have been exhausted, My Two Dogs, Inc. may suggest sedatives for grooming appointments. My Two Dogs, Inc. does NOT administer or prescribe sedatives. I understand that I must obtain a prescription from my veterinarian and administer the sedatives at home as instructed by my vet. I understand that My Two Dogs, Inc. cannot be held accountable for any negative reactions my dog may have to sedatives.
